FROM MONCKS CORNER - TAKE HWY 52/17A NORTH CROSSING TAILRACE CANAL. HEAD EAST TO JAMESTOWN. TURN LEFT AT JAMESTOWN ONTO 17A/HWY 41 HEADED TOWARD ANDREWS/GEORGETOWN. GO APPROX. 6 MILES TO OCEDA GROCERY, TURN LEFT ONTO SANTEE ROAD AND GO APPROX. 9.20 MILES. ENTRANCE TO SUTTONS IS ON RIGHT JUST PAST WILLIAMSBURG COUNTY FIRE DEPARTMENT.

FROM GEORGETOWN - TAKE HWY 521 TOWARDS ANDREWS, TURN LEFT ONTO HWY 17A TOWARDS MONCKS CORNER. STAY ON 17A UNTIL IT RUNS INTO HWY 41. TURN LEFT, GO APPROXIMATELY 1/4 MILE AND TURN RIGHT ONTO SANTEE ROAD, GO APPROXIMATELY 9.20 MILES. ENTRANCE TO SUTTONS IS ON RIGHT JUST PAST WILLIAMSBURG COUNTY FIRE DEPARTMENT.

FROM I-95 (MANNING) - TAKE 261 EXIT AND HEAD THROUGH MANNING TO HWY 52 AT SANTEE GROCERY. CROSS HWY 52 AT SANTEE GROCERY ON SANTEE RIVER ROAD AND GO APPROX. 12 MILES. ENTRANCE TO SUTTONS IS ON THE LEFT.

FROM FLORENCE - TAKE HWY 52 SOUTH TOWARD MONCKS CORNER, TURN LEFT ONTO SANTEE ROAD (ACROSS FROM SANTEE GROCERY) APPROX. 12 MILES FROM KINGSTREE. ON SANTEE RIVER ROAD GO APPROX. 12 MILES. ENTRANCE TO SUTTONS IS ON THE LEFT.
